Summary

Community foundations have existed in Canada for more than 100 years, with The Winnipeg Foundation being established in 1912.

They are organized with the local need of the community in mind and, in modern times, are a vehicle for prospective philanthropists to establish donor advised funds. As reported in The Charity Report on August 18, 2020, “a donor advised fund (DAF) is an account established when a donor makes an irrevocable donation to a foundation that houses DAFs,” in this case community foundations.

“The donor to the DAF - which could be the account holder or a third-party donor - receives a donation receipt upon making the donation. On aggregate, the foundation which holds the DAF must disburse a minimum of 3.5% of the average balance over the previous two years, but there is no annual disbursement quota for individual fund holders.

Community foundations have fully vested ownership of the DAFs, but generally follow the advice received from the donor advisors of the DAFs.

In 2020, The Charity Report also reported that, “the federal government announced a \$350 million investment, the Emergency Community Support Fund (ECSF) to “improve the ability of community organizations to serve vulnerable Canadians during the COVID-19 crisis.” and said the funding would flow through three intermediary organizations—United Way Centraide, the Canadian Red Cross and Community Foundations of Canada—who have “the ability to get funds quickly to community organizations that serve vulnerable populations.”

Summary/2

With this study, our purpose is to provide basic information about how community foundations operate, their granting priorities, their regional role in the charity sector and in broader society.

Key findings include:

- There are about 168 community foundations in Canada that cumulatively hold about \$3.7 billion in gross assets value. Together, they disbursed about 6.5% of their assets in 2018.
- 80% of the gross asset value of community foundations are held by 5 community foundations. (See complete listing in Appendix A).
- 67% of the gross asset value of community foundations are held in western Canada.

This report primarily considered the activity of the top 5 community foundations, wherein:

- Between 2008 and 2018, the gross asset value in the top 5 community foundations grew by 212%, while gifts to qualified donees grew by 163%
- In 2018, the top 5 foundations jointly spent 5.93% (182.9 million) of their combined assets on all expenditures
- In 2018, the top 5 foundations jointly spent 4.39% (145.9 million) of their assets on grants to qualified donees
- In 2018, the top 5 community foundations jointly issued 165.3 million in charitable tax receipts

Summary/3

- The top 5 community foundations disbursed all their funds to Canadian charities.
- In this report we determined the granting priorities of the top 5 community foundation by looking at the last five years of T3010 data. The top overall recipient was the University of British Columbia with a combined 5-year grant total of \$21.8 million.
- Two Indigenous-led organizations made the overall top 15 grant recipients, which both received grants from The Victoria Foundation. One Indigenous-led group made the top 15 list of The Winnipeg Foundation. No Indigenous-led organizations were represented in the top 15 grant recipients from the Toronto Foundation, the Vancouver Foundation or the Foundation of Greater Montréal.

Methodology

- The Charity Report researched the T3010s, websites and, in some cases, the annual reports of 175 community foundations across the country, using the membership of [Community Foundations of Canada](#) as a basis of its research.
- We manually looked up the T3010s of each foundations s to determine
 - Location
 - Assets
 - Expenditures
 - Disbursement percentage
 - Amount disbursed to qualified donees
 - Tax receipts issued between 2009 to 2018
 - Diversity of governance
- 2018 data was used to determine asset value.
- There were several that appeared brand new and had not made their first tax return. Others had T3010s with limited information. We ended up looking at 168 communication foundations.
- Once we determined that the top 5 community foundations held 80% of the assets of all community foundations, and disbursed 74.2% of the cohort's expenditure, we decided to focus on those to determine what kinds of organizations were receiving grants.
- [Charitydata.ca](#) was used to determine the top 15 donees for each community foundation. The top 15 donees representing 1% to 2% of the overall number of donees, garnered 35% to 75% of the total funds granted.

Methodology/2

- [Charity listings at CRA](#) was used to determine the total number of qualified donees.
- While we were conducting our research, 2019 data began to become available on [charitydata.ca](#), our main source for qualified grantee information--information that is only listed for the most recent 5 years—provided 2015 to 2019 breakdowns as opposed to the 2014 to 2018 we'd been using. For that reason, the cumulative qualified donee data contained in the report might cover 2014 to 2018 or 2015 to 2019. This is indicated in the chart labelling.
- To understand leadership demographics, we went to each foundation's website and reviewed biographical information for each board member.

What is a community foundation?

A community foundation is a registered charity and an independent *public* foundation that has two areas of business:

1. Donors can set up funds within the foundation, so they receive a charitable tax credit from the foundation. The foundation then effectively “owns” the funds, but donors can continue to direct the spending of the fund, though the foundation has the ultimate control. This is called a [donor advised fund](#) (DAF). Community foundations manage the investment of the DAFs.
2. Community foundations make grants on behalf of its account holders, vetting grant recipients. There is no current regulation governing the disbursement of DAFs. Community foundations, however, are governed by the 3.5% [disbursement quota](#) currently in place for all charitable foundations, public and private, so *in aggregate* must spend 3.5% of its assets.

Community foundations currently hold about half of the DAFs established in Canada.

The first community foundation in Canada was The Winnipeg Foundation created in 1921.

The boards of directors of community foundations are typically made up of people who can help fundraise the donor advised funds, and people who can advise on community need.

What do they spend money on?

Expenditures reported by community foundations include:

1. *Their own charitable activities*
2. *Management and administration*
3. *Fundraising*
4. *Political activities*
5. *Other expenses not covered by what's listed above*
6. *Grants to qualified donees*

Their biggest expenditures are, by far, grants to qualified donees, which accounts for 75% of their expenditures. A breakdown of the top 5 community foundations expenditures can be found in Appendix B.

Community foundations also issue tax receipts for donations and for the donor advised funds that are set up under their umbrella.

On the next page, we show the percentage of expenditures grants to qualified donees made up of total expenditures for the 168 community foundations we studied.







Top 5 growth in value of assets vs growth in grants to qualified donees, 2008 - 2018





The top 15 donees (1.5% of total donees) in 2019 received 32.4% (\$13.0 million) of the total amount granted, with an average grant of \$866,628.


Top 5 Expenditure Breakdown by Foundation

Total Disbursements, 2014 - 2018



Total Disbursements, 2014 - 2018



Total Disbursements, 2015 - 2019


